### **Synopsis:**

This is not a solicitation, but rather a Request For Information (RFI). The Saint Louis Public Schools District (SLPS) is seeking information from providers with the capacity to provide comprehensive Athletic Trainer Services for the **SLPS Public High League**.

Providers are being asked to provide information relative to the requirements of comprehensive Athletic Trainer Service program for an Interscholastic High School Athletic Program (**Public High League**) that accommodates the following:

- 1) Total Number of High Schools: 13
- 2) Total Number of Participants (Athletes): 2,982
- 3) Number of Athletic Facilities:
  - a. Baseball = 1
  - b. Basketball = 8
  - c. Football = 7
  - d. Cross Country = 0
  - e. **Soccer = 6**
  - f. Softball = 0
  - g. **Tennis = 1**
  - h. **Track = 2**
  - i. Volleyball = 11
  - j. Wrestling = 11

- 4) Number of participants per campus / per sport: See Attachment A
- 5) Schedule of Public High League 2014 2015 Games: **See Attachment B**

  - a. Athletic Training Room coverage?
  - b. Injury Prevention Program development?
  - c. Recognizing and treatment of Injuries?
  - d. Rehabilitation of injuries?
  - e. Record Keeping of Athletic Injuries?
  - f. Advisement on the needs and purchases of Athletic supplies and equipment?
