

VACCINATION COMPLIANCE 2021-2022 GATEWAY STEM HIGH SCHOOL

June 14, 2021

Pursuant to Missouri State Law, Number RSMo 167.181, requiring that every child show proof of immunization compliance before enrollment in school, all students entering 9th grade in the 2021-2022 school year must have one Meningitis A (MCV4) vaccination and a Tetanus (Tdap) booster on file. Students entering 12th grade in the 2021-2022 school year must have a second Meningitis A (MCV4) booster vaccination administered on or after their 16th birthday.

I will be mailing compliance letters to parents and guardians of students who are in non-compliance within the next few weeks. If your student does not have proof of vaccination, or an appointment letter from their doctor on letterhead stating the date, time, and location of the vaccination appointment, they will not be allowed to enroll or attend school at Gateway STEM High School.

If a student reports to school without proof of vaccination, or an appointment to receive required vaccinations, they will be sent home and excluded from in-person attendance until proof of vaccination or a doctor's appointment is provided to the School Nurse.

GETTING VACCINATIONS IS THE RULE TO RETURN TO SCHOOL

Missouri State Law Number RSMo 167.181, Saint Louis City Department of Health regulations, and St. Louis City Public Schools policy require all children to be up to date with required vaccinations **BEFORE** returning to school. If your student is non-compliant on any vaccinations required by state law, they may not return to in-person learning at Gateway STEM High School. Please contact your primary care provider early to schedule your child's appointment.
