DEADLINE REMINDER NOTICE**

<b><u>DUE DATE</u></b>	<b><u>ITEM</u></b>
Friday, May 5, 2023	Last day to submit vouchers to the Fiscal Control Office with sufficient budget and appropriate documentation. Vouchers used to circumvent established accounting and procurement policies and procedures will require additional executive approval and may be charged to next year's budget.
Friday, May 19, 2023	Last day to submit goods receipts in BusinessPlus through May 2023 for review by the Fiscal Control Office
Friday, June 9, 2023	Elementary, Middle and High Schools must complete all student activity account transactions and bank reconciliations through May 2023 for review by the Fiscal Control Office
Friday, June 9, 2023	Last day to submit year-end accrual requests for expenditures. Please provide copy of invoice or other documentation. Invoices that arrive after June 9, 2023 for materials and/or services received prior to July 1, 2023, should be forwarded to the Fiscal Control Office.
