Consortium Partnership Network Board of Directors Meeting February 22, 2019

BOARD MEETING MINUTES

The Board of Directors of the Consortium Partnership network met in Open Session on the date noted above at the Saint Louis Public Schools Administrative Building, located at 801 N. 11th St., St. Louis, MO 63130.

1. CALL TO ORDER

The meeting came to order at 2:15 p.m.

2. APPROVAL OF CPN BY-LAWS

5. MONTHLY UPDATE ON CPN ACTIVITIES

Mr. Jesse Dixon presented the following updates of recent CPN activities.

- At the January 17, 2019 Board Meeting of the Special Administrative Board (SAB) of St. Louis Public Schools (SLPS), the SAB voted on several items related to the Consortium Partnership Network (CPN).
 - The Memorandum of Understanding (MOU) between the CPN and SLPS was approved.
 - A contract with Bellwether Education Partners to serve as the facilitating partner for the CPN schools for the transition period leading up to the formal launch of the CPN on July 1, 2019 was approved.
 - o Ashland Elementary School and Meramec Elementary School were assigned to the CPN for the term of July 1, 2019 to June 30, 2022.
- SLPS Superintendent Dr. Kelvin Adams facilitated initial discussions with all staff and faculty at Meramec Elementary School (January 29, 2019) and at Ashland Elementary School (February 1, 2019) to discuss the CPN, answer questions, and outline next steps for CPN planning.
- The CPN Executive Director position was posted on the SLPS website as well as several other recruitment websites on February 8, 2019. The position will remain posted until February 28, 2019.

- SLPS Superintendent Dr. Kelvin Adams facilitated a discussion with the principals of Ashland Elementary and Meramec Elementary on February 11, 2019 to outline key next steps and present a timeline for Teacher Leadership Team convening and CPN Operational Plan Development.
- The Elected Board of St. Louis Public Schools received a formal presentation on the CPN from Dr. Adams on February 11, 2019.

6. DISCUSSION WITH VENDOR REGARDING FACILITATION OF SCHOOL TEAMS

Ms. Lina Bankert, a partner with Bellwether Education Partners who co-leads their Strategic Advising practice area, presented a short summary of efforts to date and plan of action to facilitate the Teacher Leadership Team processes at Ashland Elementary School and Meramec Elementary School which will culminate with the formation of a School Operational Plan for the Fall of 2019 for each school.
