



SYNOPSIS OF THE QUARTER 2 SCHOOL PLAN

SCHOOL: Humboldt Academy of Higher Learning

PRINCIPAL: Jacqueline Russell

INSTRUCTIONAL PLAN: Five-day-a-week in-person instruction or virtual learning, based on parent/guardian selection. Live-streaming model of hybrid instruction. Your child will keep the same teacher and the same class of students. Your child will participate either virtually or from the classroom. To continue our expansion of the Constructivist Model, all classrooms will continue to embed this model into their work. Students may have even greater opportunities to move ahead at their own pace separately, when appropriate. Your child will actively participate in class through a two-way livestream in Microsoft Teams, if attending virtually. Your child will do the same work in the same applications at the same times per day for five days per week as all other classmates, whether they attend in person or virtually. Your child will participate in related arts classes with their classmates only. Students returning to in-person instruction will travel to related arts classes and students participating virtually will attend classes through Microsoft Teams. Your child will participate in daily recess with their classmates only. Students attending virtually will be given a daily recess break at the same time. Your child will receive any and all needed and approved supports and related services, where applicable.

CLASSROOM CAPACITY: Humboldt will follow a 10-to-1 student-teacher ratio. All classes will receive additional support by an assigned Humboldt support staff member. Support staff members will support in-person and virtual learners.

SCHOOL HOURS: 9:20AM – 3:17PM plus one hour of asynchronous work to be completed at home. Please note that we are dismissing 1 hour earlier than usual. Please arrange for students to be picked up at 3:17PM each day. Make plans for your bus riders based on bus information provided by the District.

ARRIVAL PROCEDURE: All bus riders enter through Door 3. The nurse will do a daily temperature and wellness check. Students will proceed to cafeteria to pick up their hot, pre-packaged breakfast, then proceed to class. All drop-off students will enter through Door 1. The nurse designee will do a daily temperature and wellness check. Students will proceed to

cafeteria to pick up their hot, pre-packaged breakfast, then move immediately to class. Teachers will be in classrooms to receive students.

DAILY HEALTH PROCEDURE: All students (PK-5) are required to wear masks that cover their noses and mouths all day and on the bus, unless eating or actively engaging in physical activities. Staff and students will have temperature checks upon arrival. Teachers will conduct daily self-care activities for students. The counselor will conduct bi-weekly virtual class counseling and self-care sessions. If students are exhibiting signs of illness (chills, shakes, muscle pain, sore throat, loss of taste, fever, shortness of breath, cough) or have been in contact with anyone diagnosed with COVID-19, they should not be sent to school. The school is following all city mandates regarding social distancing.

MEALS: Students will eat a hot breakfast each day in their classrooms. Students will pick up breakfast from the cafeteria before going to class. Students will eat lunch in their classrooms.

VISITOR PROCEDURES: No in-person visitors are permitted in the building.

DISMISSAL PROCEDURE: All bus riders will be escorted to buses by their classroom teachers. Students will be dismissed by class. All pick-up students will report to the auditorium and sit in assigned seats (socially distanced) until the parent/guardian arrives. Students will be monitored by adults on duty. Parents will pull up in front of school to pick students up. A staff member will walk students out to parents. Parents will be required to show identification. Parents should remain in cars.
