The district offers support to students at the St. Louis City Juvenile Detention Center. The program assists the Deputy Juvenile Officers with obtaining school records for court reports, assisting students who transition back from John W. Griscom School and their assigned school, consultation regarding proper educational placement, consultation with court personnel regarding school district policies and procedures.

The formal agreement exists between the LEA and the Juvenile Justice System to serve students in institutions of incarceration. St. Louis Public Schools operates a full educational facility in the Juvenile Detention Center. The district works to ensure that staff are certified and highly qualified. SLPS provides a dedicated transitional social worker that works to ensure students enrolled at Griscom have a smooth transition back to their assigned school. The transitional social worker also creates release action plans and has transition conferences with parents, students, and assigned school staff. The transitional social worker does 30, 60, and 180 day follow up on all students. The transitional social worker also implements the character and life skills program and works closely with the Deputy Juvenile Officers to support students in transitioning to the best options.

Students are placed into the care of St. Louis City Detention Center are done so by laws and statutes that govern minors and juveniles. Upon enrollment, student's records are requested. The social worker meets with students to discuss their former educational experiences prior their admission to the center to collaboratively plan for their future educational plans. In addition to the social worker, the site school counselor and special education staff work with students to ensure all students are ready to begin in the educational program. When a student is placed in a facility, the social worker meets with the student weekly to check-in their progress, both academically and emotionally. The Deputy Juvenile Officer (DJO) meets with the social worker to receive student's records, review them, in order for them to provide appropriate support to the student.
