Who can contact BHR?

- ❖ Adults with serious & persistent mental illness
- ❖ Children and youth with serious emotional disturbance
- ❖ Community members or agencies
- ❖ Anyone in a crisis
- ❖ Law Enforcement

What happens when someone contacts BHR?

- ❖ A Masters Level or licensed clinician will help you or someone you know through an emotional crisis
- ❖ Clinicians are available 24 hours a day, 365 days a year
- ❖ Provide easy emergency access to mental health services
- ❖ When appropriate, arrange a face to face meeting with a Mobile Outreach counselor
- ❖ Give you the skills necessary to connect with community resources
- ❖ Assist with hospitalization if needed
