MINUTES

The Board of Education of the City of St. Louis met in Open Session pursuant to Board Bylaw B9350 on the date noted above at Beaumont High School located at 3836 Natural Bridge Ave, St. Louis, MO 63107.

CALL TO ORDER AND ROLL CALL

The meeting came to order at 6:31 p.m.

3. PLEDGE OF ALLEGIANCE

All recited the Pledge of Allegiance at 6:31 p.m.

4. APPEARANCES - PUBLIC COMMENTS

Ms. Gretchen Jenson shared the following comments:

- > The softball and baseball seasons were cancelled for the district this year, due to a lack of facilities, equipment, and coaches for teams, and due to the number of games last season that were forfeited or ended by the "mercy rule."
- > That decision was made by the district in May, but not communicated to parents until the fall.
- ➤ On September 19, 2018, the district held a meeting with Ms. Terron Sharp, Dr. Kelvin Adams, principals, building athletic directors, parents, and students.
- ➤ After the meeting, the district petitioned MSSHA to reinstate the seasons, and received approval for baseball but not for softball given the timing.

- > Stakeholders should have been involved.
- > Baseball and softball should be expanded to the middle school level.

Mr. Bill Monroe shared the following comments:

- ➤ How will St. Louis Public Schools address new students returning to the district due to the ending of the desegregation program?
- ➤ Mr. Bill Monroe is asking for support for Harriet Tubman High School and Career Center, proposed to be located in Beaumont High School.
- > The school will impact crime negatively 30% in the surrounding community, through education, jobs, skill building, and support of homeless individuals.
- > Mr. Bill Monroe requests to be on the agenda for the November Board meeting.

Mr. Adam Layne shared the following comments:

- > There are seven candidates running for two open positions on the school board.
- > Mr. Adam Layne is a former math teacher, who understands the potential of students in Saint Louis and who witnessed the lack of resources and supports given to teachers.

7A. UNFINISHED BUSINESS: DISCUSSION OF SUPERINTENDENT DR. ADAMS' SEPTEMBER 11TH TRANSFORMATION PLAN PRESENTATION

A discussion took place on the Transformation Plan Presentation given by Superintendent Dr. Adams' on September 11, 2018:

- Ms. Katherine Wessling commented on her support of year-round schools.
- > Vice President Charli Cooksey and Ms. Susan Jones commented that this discussion could be integrated into transition training sessions or into future work sessions.
- Ms. Susan Jones asked how year-round school has worked in other urban cities.
- > Mr. Bill Haas commented that the first step would be to ask Dr. Adams for his input into the issue, including associated costs and possible sources for those funds.
- ➤ Ms. Donna Jones commented on the financial burden for parents with added months to the school calendar, on the value of summer vacation, and on the importance for older

- children of summer jobs. Ms. Donna Jones also commented that parents should be surveyed. Ms. Donna Jones also commented on the possibility of students earning a summer stipend for year-round schooling.
- ➤ Vice President Charli Cooksey commented on whether Transformation Plan 3.0 is ready yet and written out in greater detail. How have the strategies in the Transformation Plan 3.0 been informed by evidence and research, and how have they demonstrated success in other regions or in this district in the past?

7b1. UNFINISHED BUSINESS: TRANSITION/ TRAINING: UPDATE: NSBA/MSBA BOARD GOVERNANCE TRAINING SESSION: OCTOBER 13TH/ OCTOBER 14TH

President Dorothy Rohde Collins commented on the following:

- > Deadline for adding agenda items has always been prior to the posting of the agenda.
- > The Work Flow document was never voted on and is not a board policy, and therefore should be called a "suggested deadline" instead of a "deadline."
