# **BUDGET AMENDMENT BASICS**



- State law requires that a budget amendment be made prior to actual expenditures for a given fund exceeding the officially approved budget for that fund
- The budget amendment should be noted in the board minutes

# **GOB BUDGET AMENDMENT#1**

## □ Revenues: +\$30M

- > Proposition C: \$8M
- > Deseg Sales Tax: \$5M
- > State Aid: \$6M
- > Transportation: \$6M
- E-Rate: \$5M
- > Amended Total Revenues = \$335M

## □ Expenditures: +\$9.8M

- > Salaries: \$6.75M
- Benefits: \$1.85M
- > Purchased Services: \$1.4M
- > Supplies & Materials: (\$0.2M)
- > Amended Total Expenditures = \$312M
