Background on Confluence Sponsorship

Confluence Academies in second year of five-year contract term with DESE. (2022-2023 through 2026-2027)

December 2022- Sponsorship Approved by Saint Louis Public Schools and Confluence Academies.

July 2023- Sponsorship Agreement with SLPS/ Confluence began.

School Visits

SEPTEMBER: Initial Beginning of Year visits to all school

QUARTERLY: Feedback visits

- Quarter 2 (November/ December): Facilities Walk-throughs
- Quarter 3 (January/ February): Classroom Visits, IEP Process and Document Review, Human Resources Interviews
- Quarter 4 (March/April): Review of Curriculum, PD, Technology, Strategic Planning, and Board Leadership

Performance Agreement

Success-Ready Students Network (state DESE waiver):

- Confluence will still take all MAP assessments.
- Confluence will still receive an MSIP 6 APR result (for Federal purposes, including Comprehensive Status identification)
- Confluence will also receive an Alternate APR result, based on local assessments (NWEA).
- Alternate APR system will to be collaboratively developed over the next three years with DESE and other SRSN districts.

Performance Agreement updated to reflect use of Local Assessments (with a focus on all students growing).


Final Agreement to be voted on at next Confluence Board Meeting on December 14.
