- 6. There will be 30 minutes allotted for <u>all comments</u>. If you were not called to speak, you may submit your information in writing or return to the next scheduled meeting with a priority number.
- 7. Only one person, individual or group, should speak to the <u>same point on any one topic</u>. (In other words, if your opinion has been stated, please do not repeat it.)

For your convenience, we will continue to <u>live stream Board Meetings</u> and post them to the website (slps.org/virtualboe). (Board Work Sessions are open to the public but will no longer be live-streamed).

Finally, please understand that members of the Board of Education of the City of St. Louis are volunteer officials who give up their time and talent to support students and teachers across the District.
