# **Position Summary:**

The Clinical Consultant- Risk Intervention member is a member of the clinical social work team and works under the supervision of the Manager of Social Work Services. The Clinical Consultant-Risk Intervention Response Team performs duties such as educating school personnel of current trends in youth mental health, wellbeing, and suicide prevention and awareness. The Clinical Consultant-Risk Intervention Response Team will support staff in implementing district protocol regarding suicide risk and harm to other assessments and ensure students have education and resources in place to support their mental health needs and physical safety.

# Essential Functions:

- Participate in train-the-trainer workshop offered by Comprehensive School Threat Assessment Guidelines (CSTAG)
- Train district social workers, counselors, and nurses in the guidelines identified by CSTAG as well as district policy and procedures surrounding risk assessments
- Create standardized presentation surrounding district's risk assessment policy and procedures and train school social workers to provide this training to all school-based staff
- Provide supplemental training/support to staff administering risk assessments when a lack of competency has been demonstrated
- Respond to school site when a need arises and no staff who has been trained in administering risk assessments are present
- Participate in scheduled After Care Conferences following high risk assessments
- Provide support to school-based staff in identification of appropriate resources, interventions, and systems to assist in ensuring the students' and the schools' safety
- Provide age appropriate education and information to all students in grades 5-12 regarding mental health, well-being and suicide prevention and awareness
- Maintain risk assessment documentation and collect and analyze assessment data
- Serve as a clinical care and program subject matter expert when participating in all relevant meetings and advance expertise through trainings in accordance to St. Louis Public Schools policies
- Maintain records as required by state and district requirements
- Remain cognizant of and comply with district, state and federal laws that govern delivery of special education services
- Attend workshops, in-services and staff meetings
- Perform all other duties as assigned by the Manager of Social Work Services

## Knowledge, Skills, and Abilities:

- Ability to apply principles of logical thinking to define a problem, collect data, draw a valid conclusion, develop and execute a treatment plan to achieve progress
- Ability to effectively express ideas orally and in writing



- Ability to collaborate and build relationships and understand what motivates others
- Knowledge of appropriate responses to suicidal ideation/statements
- Driver's license and vehicle for travel among schools
- Ability to work independently, schedule and utilize time to best serve the designated school district
- Conduct effective training in the area of suicide prevention and response
- Knowledge of the organization and communication channels of a school system

#### Experience:

- Post-graduate experience working with children and adolescents and providing therapeutic services
- Training or experience in trauma informed treatment

### Education:

- Master's degree in mental health counseling, psychology, or social work
- State of Missouri LCSW, LPC, or equivalent

### **Physical Requirements:**

- Must be physically able to operate a motor vehicle
- Must be able to exert up to 10 pounds of force occasionally, and/or a negligible amount of force constantly to lift, carry, push, and pull or otherwise move objects, including the human body
- Light work usually requires walking or standing to a significant degree

## Working Conditions and Environment:

- Work is routinely performed in a typical interior/office environment
- Very limited or no exposure to physical risk
