## New and Improved

### **AESM at L'Ouverture Middle School** *(City residents only)*

The Academy of Entrepreneurship Studies Middle School is being established at the L'Ouverture School for 6th, 7th and 8th grade applicants. At AESM, students develop the skills, knowledge and experience to shape their own futures and succeed in the global economy.

### **Gifted Program at Columbia Elementary** *(Grades PK4-1)*

Columbia now serves as one of the three full curriculum certified gifted public elementary schools in the St. Louis region offered by the Saint Louis Public Schools. Utilizing the same accelerated curriculum used at Kennard and Mallinckrodt, teachers create a warm and challenging environment for students who have been tested and identified as gifted.

### **Gifted Application**

For the first time, the SLPS Gifted Program magnet schools will have an application separate from the General Education magnet programs. Elementary Gifted Education Program applicants may submit placement requests for all four Elementary Gifted Education Program Options with preferences ranked from one to four (only one choice is required). In addition, Gifted Education Program applicants for all Gifted Program Schools may also apply for up to two General Education Program Magnet Schools if desired, to be considered for placement prior to required testing being administered.

# Eligibility

To qualify for SLPS magnet schools, you must meet one of the following two residency requirements:

- Be a resident of the City of St. Louis.
- Be a non-African-American student entering grades K-12 and live in the Affton, Bayless, Brentwood, Clayton, Hancock Place, Kirkwood, Ladue, Lindbergh, Mehlville, Parkway, Pattonville, Ritenour, Rockwood, Valley Park or Webster Groves school districts.

*-Please note: County residents are not eligible for SLPS pre-kindergarten or choice schools (AESM @ L'Ouverture, Northwest, Carnahan, Clyde. C. Miller)*

# Application Process

## Gifted

1. Go to [www.slps.org/magnet](http://www.slps.org/magnet) to submit an application for up to 4 schools.
2. Applications will be screened by the Gifted Office.
3. If your child meets the criteria, a testing appointment will be scheduled and he/she will move to the lottery. If your child does not meet the criteria, he/she will not move forward to the lottery.

## Magnet and Choice Schools

1. Go to [www.slps.org/magnet](http://www.slps.org/magnet) to submit an application for up to 2 schools.
2. Applications will be screened by the schools. If applicable, submit additional required materials to those schools.
3. If your child meets the criteria, he/she will move to lottery. If your child does not meet the criteria, he/she will not move forward to the lottery.
