# **School Parent and Family Engagement Policy**

### **Strategies for Involvement**

We will remain steadfast and committed to providing a variety of opportunities for parents to involve themselves in their child's education and will ensure that parents are made aware of items pertaining to their child's education as well as information regarding to Title 1 mandates.

- Sigel Elementary School will host a Back to School Social/Open House. This will be held one
  week before school starts. It will be an opportunity for parents to meet and discuss the new
  curriculum and meet their child's teacher and school staff.
- Sigel Elementary School will work diligently to assist interest parent's/family members to establish a Parent Teacher Organization (PTO) and subsequent provide space for meeting and family events (e.g. Family MAP Night, Math & Literacy Night, Parental Information, etc.) throughout the school year with alternating morning and evening times. These meetings will inform parents of all school updates and will give parents a vehicle to discuss any school related problems or parental issues. The events will help equip the families with techniques and tips to prepare students for success and also provide support to parents in order to aid their students in succeeding.
- We will conduct Bi Annual Title 1 meetings (to be held in the Dall and Spring semesters) to
  inform parents of Sigel's participation in Title 1 programs. We will inform parents of all Title
  1 mandates including: Parent's Right To Know, Every Student Succeed Act, Title 1 and SLPS
  District Complaint Resolution Procedures and the Title 1 parent engagement policy. Our
  Family and Community Specialist will host these meetings.

• To encourage communication with parents, Sigel Elementary School schedules (2) parent conference per year.
